

- 4) that the college will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4<sup>th</sup> February, 1987 (copy enclosed.)
- 5) that college should follow the norms as prescribed and circulated by the University vide No.CONCOL/75 of 1988, dated 3<sup>rd</sup> March, 1988 (copy enclosed).
- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.


